I wrote recently via email and hope you might get back to me regarding the offer below?

I am Stafford Borough Council's Partnerships Co-ordinator, with a remit to support sustainable development initiatives.

You may be aware of the sustainability webpages here: <http://www.staffordbc.gov.uk/sd> and I am sure you will have seen the publication 'Newsleaf' which gives a quarterly summary of sustainability items from around the Borough:

One part of the sustainability agenda which is currently growing rapidly is cycling and recently SBC have recently installed a number of Public Cycle Pumps in Stafford which have been well received and used.

I am emailing now to see if you think that a Public Cycle Pump facility would be of use in Stone? You can see the kind I mean by looking at page 8 of current edition of Newsleaf – or the photos attached.

I am able to provide one public cycle pump free of charge and including installation by Streetscene.

Please could you let me know if this would be of interest?

If so, it would then be necessary to identify the most appropriate site and consider permissions that might be required.

It might be useful to consult with local cyclists for instance via the Stone Wheelers (details of Chairperson below) or the Bike Shack, with reference to potential siting.

Perhaps more than one Public Cycle Pump would be useful, in which case perhaps further funding could be sought.

I am very happy to come and see you to discuss this possible project. Please can you get back to me to let me know what your thoughts are.

I may also be able to help with the installation of cycle parking stands, for instance at community centres, schools, churches or shopping parades, and would also be happy to discuss this.
