Development – Advertisement signage

Location – Stone Fire Station, The Fillybrooks, Stone

Development – Change of use of part of the site to accommodate light goods vehicle testing at Stone Fire Station

Observation – Members object most strongly due to noise, disturbance of neighbouring residents and potential parking issues in residential area Members suggest a better location would be on the Walton Industrial Estate. Concerns were also raised that additional time was given to Members for their comments, but the call-in date had been missed.
