Applicant - Mr H. Khadar

Location – 13 High Street, Stone

Development – Change of use to ground floor from two retail units to mixed Sui Generis use including sale of hot and cold food A5/A3 and including sale of hot and cold desserts

Amendments – External flue to the side, facing no. 11 High Street, has been added to the application for Environmental Health purposes. The amendment has altered the red edge and the description.

Observations: The Town Council wishes to repeat its observations made in response to the original plans, submitted in a letter to Stafford Borough Council on 4 November 2020:

The Town Council would welcome a daytime hot and cold food takeaway provision to add to the amenities of the town. However, it would not support evening takeaway services which could increase the flow of traffic in the High Street, on street parking and other consequential risks.

Please also note that the Town Council supports the Conservation Officer's recommendations.
