<p>Contracts Any contract which is made between the relevant person (or a body in which the relevant person has a beneficial interest) and the relevant authority:</p> <p>(a) under which goods or services are to be provided or works are to be executed; and</p> <p>(b) which has not been fully discharged.</p>		
<p>Land Any beneficial interest land which is within the area of the relevant authority.</p>

<p>Licences Any licence (alone or jointly with others) to occupy land in the area of the relevant authority for a month or longer.</p>		
<p>Corporate tenancies Any tenancy where to your knowledge:</p> <ul style="list-style-type: none"> (a) the landlord is the relevant authority; and (b) the tenant is a body in which the relevant person has a beneficial interest. 		
<p>Securities Any beneficial interest in securities of a body where:</p> <ul style="list-style-type: none"> (a) that body where to your knowledge has a place of business or land in the area of the relevant authority; and (b) either: <ul style="list-style-type: none"> (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.
