<p><b>Contracts</b> Any contract which is made between the relevant person (or a body in which the relevant person has a beneficial interest) and the relevant authority:</p> <p>(a) under which goods or services are to be provided or works are to be executed; and</p> <p>(b) which has not been fully discharged.</p>

<b>Licences</b> Any licence (alone or jointly with others) to occupy land in the area of the relevant authority for a month or longer.		
<b>Corporate tenancies</b> Any tenancy where to your knowledge: <ul style="list-style-type: none"> <li>(a) the landlord is the relevant authority; and</li> <li>(b) the tenant is a body in which the relevant person has a beneficial interest.</li> </ul>		
<b>Securities</b> Any beneficial interest in securities of a body where: <ul style="list-style-type: none"> <li>(a) that body where to your knowledge has a place of business or land in the area of the relevant authority; and</li> <li>(b) either:               <ul style="list-style-type: none"> <li>(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or</li> <li>(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.</li> </ul> </li> </ul>
